A FLORIDA BROWNFIELDS FRAMEWORK FOR TRANSACTING AND REDEVELOPING PFAS IMPAIRED SITES

This panel will offer a detailed summary of evolving legislation in the U.S. Congress as well as US EPA

initiatives to create statutory and administrative liability exemptions for certain categories of stakeholders, discuss recent legislation proposed in the Florida Legislature to provide certainty and flexibility for parties conducting voluntary cleanup, unpack the existing legal framework of the Florida Brownfields Program and explain how it can be used to insulate against state and federal liability, and share up-to-the-minute insights into how the environmental insurance markets are responding and whether coverage is available for buyers, sellers, lenders, and end-users. A risk analysis case study will be presented by an experienced brownfield developer who has a major PFAS impacted landfill under contract to acquire.

CRUSHING BROWNFIELDS INCENTIVES YIELDS FINE WINE

The perfect recipe for Brownfields Revitalization was concocted and prepared with collaboration among the city, the applicant's attorney, the City's consultant, and the FDEP. This strong partnership aided in the planned renovation/conversion of a vacant former industrial machine shop in Jacksonville's Brooklyn neighborhood (built in 1954), from idle unused property to a wine bar and shop. Through use of the City's EPA Brownfields Assessment Grant funds, due diligence was conducted through an iterative process that included Phase I and II ESAs, an Analysis of Brownfields Cleanup Alternatives, as well as asbestos and lead containing paint surveys. The alliance with the City enabled streamlined permitting, while the City's consultant worked closely with the grant applicant's attorney, selling party and FDEP to foster a successful plan to reach the redevelopment vision of the site. This project epitomizes the goals of the EPA, the local Brownfields designation process, FDEP state Brownfields incentives, strong consulting, and interagency partnerships.

BROWN WITH ENVY: A FLORIDA LEGISLATIVE WISH LIST BASED ON EXISTING LEGISLATION IN OTHER STATES

Michael Goldstein, Goldstein Environmental Law This presentation will offer a comprehensive evaluation of Brownfield legislation in the other 49 states and identify which statutes from those states could be adopted in Florida to fill a need (and why that need exists). We will also provide a critical analysis of the existing statutory framework in Florida and the ambiguities and gaps that exist which create legal, regulatory, and financial uncertainty and limit impaired sites from being sold, financed, cleaned up, and redeveloped. Specific legislative fixes will be proposed, with emphasis on creating more opportunity for local governments. Finally, a survey of pending and possible federal brownfields related legislation will be discussed in the context of additional financial, regulatory, and legal resources that could be available if taken up by the US Congress. This presentation is designed to achieve three major objectives: (i) identify hidden gaps in the existing Florida and federal legislative framework that can trip up novice or unsuspecting project principals, local government officials, and community advocates; (ii) identify and highlight innovative legislative solutions created by other states that would benefit Florida stakeholders if enacted in Florida; and (iii) propose a robust state legislative agenda for the 2024 session and for the next US Congress that can be utilized as a starting point for the FBA and/or aligned parties.

USING FOOD PRODUCTION AS A COMMUNITY REVITALIZATION STRATEGY FOR BROWNFIELD REDEVELOPMENT

The purpose of this session is to show the audience how food production can be used as a tool to foster revitalization and economic development in distressed communities. Through EPA's Brownfields Program, the East Central Florida Regional Planning Council (ECFRPC) started working with Little Growers, a grassroots community-based organization in Brevard

County's Crane Creek/Booker Heights neighborhood. This historically unincorporated African American community is home to about.6,000 people. The community's median household income is 42% lower than the rest of Brevard County, and close to a quarter of its residents live below the federal poverty line.

THE ENVIRONMENTAL CONNECTION TO SARCOIDOSIS | Steve Hilfiker, ERMI

Sarcoidosis is an immune system disorder that I do not believe to be as rare as the literature suggests, based on my experience surviving cardiac sarcoidosis with a heart transplant. The literature indicates there is a genetic predisposition and an environmental trigger. This has been found to be true from 42 interviews with clinicians and Sarcoidosis Warriors I have conducted throughout the world. Many interviewees recite specific exposure to contaminated sites as their Environmental trigger. Sarcoidosis can affect the eyes and skin, which would be absorption, lungs and heart which would be inhalation, and internal organs which would be through ingestion exposures. Toxicological research opportunities will be discussed. It is well known that many 9/11 victims developed sarcoidosis due to dust inhalation. It is speculated that the high incidence of sarcoidosis among policemen is due to inhalation of firearm emissions. It is believed that the high incidence of sarcoidosis among firefighters is due to smoke inhalation. I believe my case was related to allergies to green tree pollen. In this discussion we will review the environmental triggers of sarcoidosis, discuss exposures, and review my case study as an example. Methods of early detection for the disease will be presented along with the general symptoms and messages of awareness for members of The Association to be able to communicate with their friends and family, the symptoms, and signs of sarcoidosis. The general themes of public Health and environmental justice apply substantially to this topic and these items will be further addressed in the seminar.

ANNUAL ENVIRONMENTAL JUSTICE AND EQUITY COMMUNITY CAUCUS & LISTENING SESSION

Historically, the Florida Brownfields Association Environmental Justice and Public Health Committee has hosted a Community Caucus which serves to have community members introduce themselves and provide a brief introduction of their communities and their specific issues. This is followed by a roundtable listening session with environmental justice communities and a broad range of stakeholders present. The issues expressed during the session will be summarized by a college level student(s) and serves as an educational asset. The intent of the Listening Session is to hear from impacted communities about their challenges and successes on a Statewide basis from an Environmental Justice, and Equity and Brownfields redevelopment perspective. Multiple local and statewide and national Environmental Issues, challenges and successes will be discussed from throughout the state. The session also serves to connect communities with resources and provides an opportunity for community stakeholders to network and meet individuals who can have an impact in their communities.

BEYOND BROWNFIELD BASICS: UNDERSTANDING ALTERNATIVE APPROACHES UNDER CHAPTER 62-780, F.A.C

The presentation will include a brief overview of the concept of contaminated site closure in Florida under Chapter 62-780, F.A.C., and Risk-Based Corrective Action (RBCA). It will introduce terms and acronyms for those who are new to the field and give an overview of conditional closure options and the commonly used Institutional Controls (IC) and Engineering Controls (EC). Jennifer Codo-Salisbury, Central Florida Regional Planning Council (CFRPC); Daphne Green, East Central Florida Regional Planning Council (ECFRPC); Stephanie Heidt, Treasure Coast Regional Planning Council (TCRPC) "Beyond Brownfield Basics." Specifically, the presentation will describe how a contaminated site can receive a "Site

Rehabilitation Completion Order" (SRCO) or a Conditional SRCO (C-SRCO), as applicable, under Subsections 62-780.680(1), (2) or (3), F.A.C.; i.e., Risk Management Option (RMO) I, II or III, *or* a combination thereof using a hybrid approach.

DOLLARS AND SENSE, CONNECTING THE COMMUNITY THROUGH BROWNFIELDS

The City of Oviedo acquired former agricultural land (approximately six acres) in the historic downtown area to construct a large stormwater retention pond to provide drainage solutions to the surrounding area. The creation of this pond would manage runoff in hopes that flooding will be diminished and the other waterways in Oviedo would not be overburdened. The design included green space with Florida-Friendly Landscaping for beautification and community gatherings and a walking trail to promote health and wellness. This space was designed for function as well as to enhance property values and promote biodiversity in the area.

THE TALE OF TWO BSRAS – A CASE STUDY ON OPTIMIZING BROWNFIELDS REDEVELOPMENT AT A FORMER SOUTH FLORIDA LANDFILL

F. Joseph Ullo, PE, ESP, Shareholder, Carlton Fields; David Latham & Cristina Graver, Geosyntec (Sponsor) The Former Town of Palm Beach Landfill operated as a landfill, transfer station, and incinerator from the early 1940s through the late 1950s. It reportedly closed in the 1950s and then reopened sometime thereafter for the disposal of vegetative waste through approximately 2015 but is currently inactive. Fast forward to 2019, a private developer started the process for redevelopment of the landfill for mixed use including a work force housing component. The proposed redevelopment includes both the permitted

portion of the inactive landfill and the surrounding areas of the Site. As part of the environmental due diligence and site assessment activities, it was discovered that buried waste was present outside the limits of the permitted landfill area as well as impacted soil, the presence of landfill gases, and impacted groundwater. The private developer decided to enter into a Brownfields Site Rehabilitation Agreement (BSRA) for the groundwater impacts associated with the landfill; however, since additional cleanup is required under brownfields in the unpermitted area, a second BSRA was negotiated with the Florida Department of Environmental Protection to address that portion.

SEEKING ENVIRONMENTAL JUSTICE FOR THE NORTH PORT ST. JOE COMMUNITY

This presentation will provide updates to ongoing efforts in the community of North Port St. Joe, Gulf County, Florida to address a myriad of issues, including environmental contamination, poor housing infrastructure, access to fresh foods, community revitalization and water infrastructure concerns. The community will also discuss the proposed liquified natural gas export and storage facility that will bring greater cumulative impacts to an already overburdened minority community. The community is building a coalition of partners, including the Florida Brownfields Association, to address longstanding contamination issues caused by the St. Joe Paper Company, which polluted the air, water, and soil with a wide range of environmental toxicants for over 50 years. With funding from the U.S. EPA, and other funders, the community has embarked on a collaborative problem-solving grant, a communitywide assessment grant, and an environmental workforce development grant, as well as efforts to address water infrastructure and health concerns. The presentation will describe the current efforts, lessons learned, challenges and next steps. The audience will be invited to provide feedback on ongoing efforts and

redevelopment strategies in place and moving forward.

RESEARCH TO INFORM THE PORT ST. JOE HEALTH (IN)EQUITY ASSESSMENT

We will begin the session with a broad overview of Cleanup Grant resources to aid in redevelopment, including some available for solid waste removal. From there we will focus specifically on solid waste.

IT'S PAST TIME! AN ENVIRONMENTAL JUSTICE COMMUNITY'S PERSPECTIVE

The community of Tallevast was once independent and thriving. Tallevast has declined due to significant health, environmental, and economic issues. Family Oriented Community United Strong (FOCUS) was

formed in the early 2000s to revitalize the community but was derailed by the discovery of contamination. and community exposure. Twenty years later, the community is in its greatest state of disrepair and longs to return to a thriving community. This requires FOCUS to return to revitalization efforts, working holistically with a group of diverse stakeholders. Through a partnership with FOCUS, and other stakeholders University of South Florida was able to secure an EPA Brownfield Grant to assist the community as it endeavors to create a new vision. better understand health implications of the contamination, and leverage other funding sources to develop to create systemic internal and external processes to expand community engagement and to formalize a collaborative process with existing and new partners to find solutions to the environmental and health challenges in Tallevast. Additionally, FDEP has awarded FOCUS with funding through its Targeted Brownfields Assessment program. This panel consists of community leaders, USF's Director for its Center of Brownfields Research and Redevelopment and the community's environmental consultant who will share a unique perspective on community challenges and how the collaborative is using Brownfields and other programs to help the community to move forward. It is way past time!

"WHAT'S THE STORY" HOW GIS CAN TELL THE BROWNFIELD STORY.

CAPACITY BUILDING FOR BROWNFIELDS REDEVELOPMENT: THE EJ40/67 PROJECT

E. Christian Wells, University of South Florida; Richard D. Schulterbrandt Gragg III, Florida A&M University Both the U.S. Environmental Protection Agency and the Florida Department of Environmental Protection would like to identify communities with brownfieldsrelated environmental justice challenges in Florida and build capacity in these communities for applying for state and federal resources to pursue brownfields redevelopment. This desire is in response to recent funding opportunities (Bipartisan Infrastructure Law, Inflation Reduction Act) but especially the White House's Justice 40 Initiative (Executive Order 14008, Section 223), which directs 40% of the benefits of certain Federal investments (brownfields remediation, clean energy, affordable housing, clean water infrastructure) to underserved communities impacted by pollution and contamination. In response, our EJ40/67 Project—an initiative created and supported by the FBA's Environmental Justice and Public Health Committee—is developing a suite of methods to locate these communities within each FDEP District and to identify formal or informal community-based organizations that might wish to receive technical support for brownfields redevelopment.
