PRIORITIES EMERGE

As the third interim committee week was wrapping up on Thursday, Speaker Paul Renner took the opportunity to announce a bold expansion of Florida's educational scholarship programs. Filed by Sebring Republican Representative Kaylee Tuck and co-sponsored by Representatives Fine, Leek, Plasencia, Sirois, and Snyder, the School Choice bill was awarded the coveted HB 1 slot (House leadership typically "reserves" the lower-numbered bill numbers for their top priority items).

The bill would expand the eligibility to participate in the Family Empowerment and Florida Tax Credit Scholarship Programs to every student statewide – regardless of income or socio-economic status. Children from lower-income families would still get first priority, and the legislation would allow for payments to go to the parents of children who are home-schooled. Speaker Renner stated that the bill's intent is to provide "educational freedom" for everyone. House Minority Leader Fentrice Driskell responded by stating, "This is a continuation of Republican attacks on our public education system that helped create the American Dream by providing education to the poor and rich alike." The measure also drew praise from Senator Kathleen Passidomo and from former Governor Jeb Bush, who was the original architect seeking to establish these programs.

While no Senate companion has yet been filed, HB 1 is on the fast track. Shortly after being filed, committee references were assigned and the bill will be on the House Choice and Innovation Subcommittee next Thursday.

LEGISLATIVE COMMITTEES

For the third consecutive interim committee week, very little substantive legislation was included on any of the agendas. Instead, most committees heard presentations from state agencies and councils on general topics relevant to their respective committees.

Both chambers will reconvene next week (January 23 – 27) for the fourth interim committee week. Copies of the House and Senate agenda calendars are included below.

UPCOMING EVENTS

On Thursday, January 12, the GrayRobinson team and members of the FBA met with the Florida Department of Environmental Protection Division Director for the Division of Waste Management Tim Bahr and Legislative Affairs Director Alex Kirnen (Bickley) to discuss the Association's legislative agenda for 2023 regarding the Voluntary Cleanup Tax Credit Program. Draft language for consideration, including a history of VCTC funding, was provided to the Department. Based on their feedback, it is anticipated that once the VCTC applications have all been submitted, the backlog would increase to approximately \$27.5 million, as was reflected on the materials we shared with them.

The Florida Brownfields Association Strategic Planning Meeting and Legislative Event has been scheduled for February 6-7, 2023. GrayRobinson staff will work to secure meetings with legislators and staff to discuss FBA's 2023 priorities upon the announcement of committee block schedules for that week.
